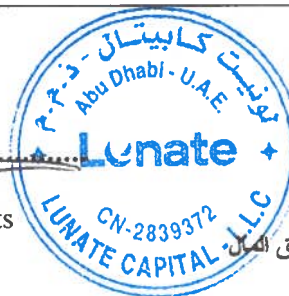
Noting that the name changes of the Umbrella Fund and its Sub-Funds reflect the rebranding of the Management Company to "Lunate Capital LLC" and seeks to align the Umbrella Fund and its Sub-Funds under a consistent brand with the Management Company. Noting that the change of name does not entail any change to the legal entity of the Fund, its investment objectives, policies, fees, or the rights of unitholders. All other terms and conditions remain unchanged.
